




# Defense Medical Information Exchange Joint Legacy Viewer Health Information Portal



The Joint Legacy Viewer (JLV) is managed within the Department of Defense (DoD) by the Defense Medical Information Exchange (DMIX) Program, under the Program Executive Office Defense Healthcare Management Systems (PEO DHMS).

## WHAT IS THE JOINT LEGACY VIEWER?

JLV is a clinical application that provides an integrated, read-only display of health data from DoD, Department of Veterans Affairs (VA), and private sector partners in a common data viewer. Thousands of DoD and VA clinicians use JLV daily to access real-time medical data in the treatment of their patients. The application also supports thousands of benefits administrators as they research patient medical histories to process claims.

DMIX worked with DoD and VA user communities to determine features most important to end users. The customizable display allows an individual to view patient data through any of JLV's health information widgets. Data displays chronologically and can easily be identified by the site of care. DoD data displays as an orange square, VA data displays as a blue circle, and private sector care displays as a purple hexagon.


