**c. Describe the purpose of this DoD information system or electronic collection and describe the types of personal information about individuals collected in the system.**

The Enterprise Intelligence and Data Solutions (EIDS) Program Management Office (PMO) Military Health System (MHS) Information Platform's (MIP's) fundamental mission is to provide a comprehensive solution capable of supporting the evolving clinical and business data needs within the MHS and the DHA (Defense Health Agency), spanning across Defense Health Headquarters (DHHQ), Defense Health Networks, Military Treatment Facilities (MTFs), research communities, managed support contractors, combatant commands, and Health Information Exchange (HIE) partners including Veterans Affairs (VA) and other Federal entities. The MIP is a suite of data persistence, informatics, artificial intelligence, data science tools, and data mart solutions. MIP hosts predictive, diagnostic, and descriptive tools for information delivery that include: CarePoint information Portal, dashboards and reporting services, and external applications. With data input from numerous separate legacy systems, multiple data repositories, and MHS Genesis, the MIP enclave provides a range of services, such as intelligence and analytics, clinical quality management, patient administration, medical management, population health, manpower/personnel, mental health, logistics, and military readiness across a set of enterprise reporting and clinical cohort management databases. The MIP enclave is hosted in Amazon Web Services (AWS) GovCloud.

MIP has incorporated legacy data from decommissioned systems and is the authoritative data source for the entire longitudinal patient health record. Patients input data directly into MIP that is provided to other medical systems.
