c. Describe the purpose of this DoD information system or electronic collection and describe the types of personal information about individuals collected in the system.

The purpose of the Joint Longitudinal Viewer DoD (JLV-DoD) system is to host the JLV Web application (JLV), which is a custom Government Off-the-Shelf (GOTS), patient-centric, read-only web-based application that provides a single, comprehensive view of a patient's electronic health record (EHR) to authorized Department of Defense (DoD) health care providers. The JLV-DoD application supplements DoD's primary Electronic Health Record (EHR) applications by providing access to disparate clinical data from over 340 data sources. In effect, the JLV-DoD application helps to provide DoD clinicians access to a patient's "complete" longitudinal medical record, which helps to make the most informed decisions in order to provide the most comprehensive health care available to the patient.

Clinicians access JLV through a Provider Portal that provides PHI/PII specific to the clinician's patients, including demographic information, personal contact information, employment information, citizenship, military records, race/ethnicity, birth date, disability information, marital status, child information, DoD ID number, emergency contact, sex, medical information, name, other ID number, PHI, religious preference, and social security number (SSN). The PHI/PII is displayed in a consolidated collection of widgets for the corresponding clinical data types. PHI/PII is collected from active duty service members and retirees of the seven uniformed services, their family members, survivors, members of the National Guard and Reserves and their families, others who are registered in the Defense Enrollment Eligibility Reporting System (DEERS), and providers.

JLV is accessible from Military Treatment Facilities (MTFs), Medical Centers, Clinics, and Hospitals. JLV is also accessible at multiple locations by authorized users affiliated with the Defense Healthcare Management System (DHMS), such as trainers, engineers, and functional users (clinicians) for development, testing, training, and troubleshooting. The system is not publicly available and can only be accessed with a CAC on a DoD network by an authorized user.

d. Why is the PII collected and/or what is the intended use of the PII? (e.g., verification, identification, authentication, data matching, mission-related use, administrative use)

PII/PHI is collected for the provision of health care services and administrative use. The PII is used to provide a common data view of patient information from many separate and distinct electronic medical record systems in one place (JLV viewer), for the purpose of enhancing the timely and comprehensive provision and delivery of healthcare services.

The JLV-DoD system does not collect PHI/PII directly from individuals and is not the initial point of collection for any PHI/PII.
