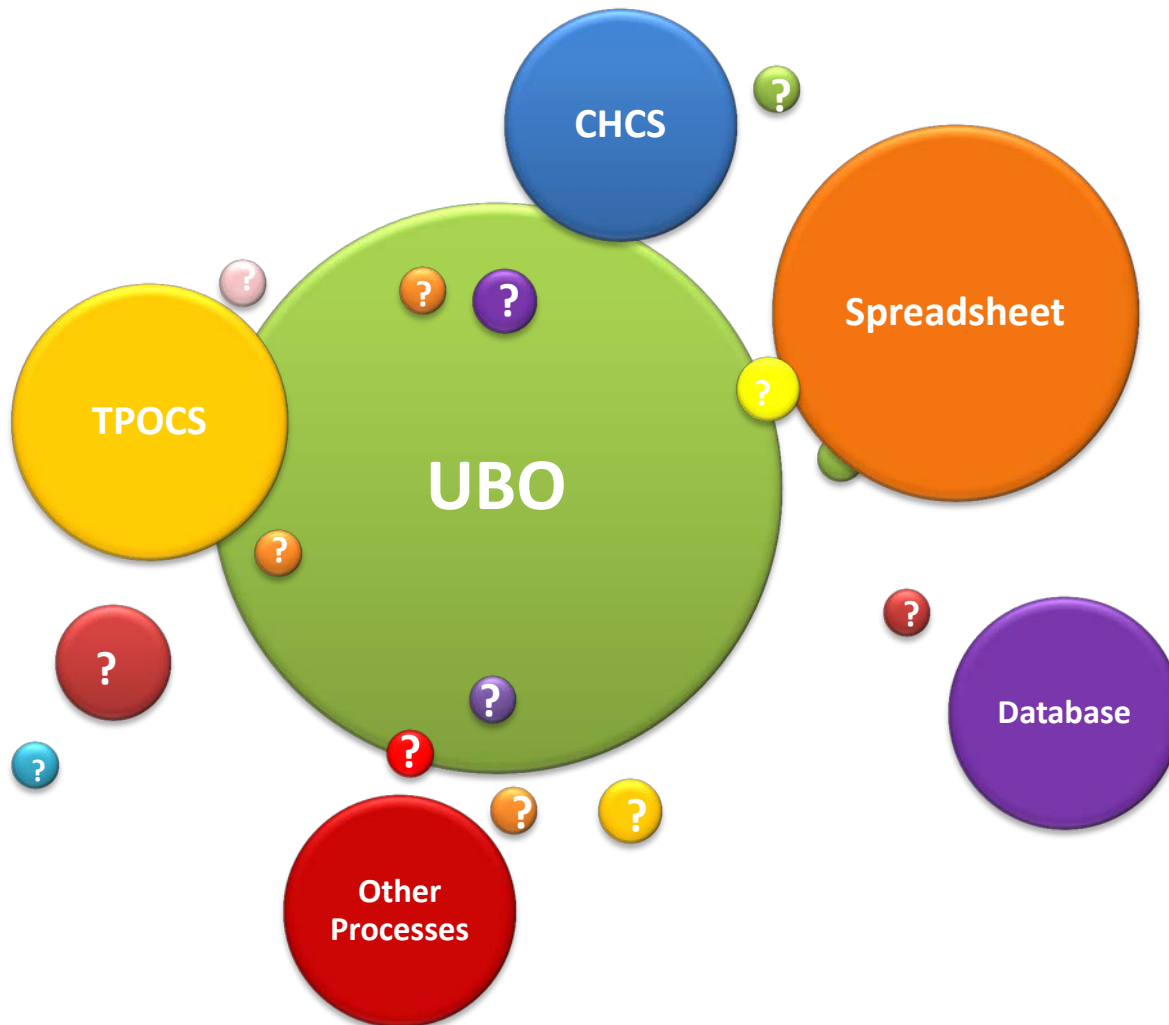

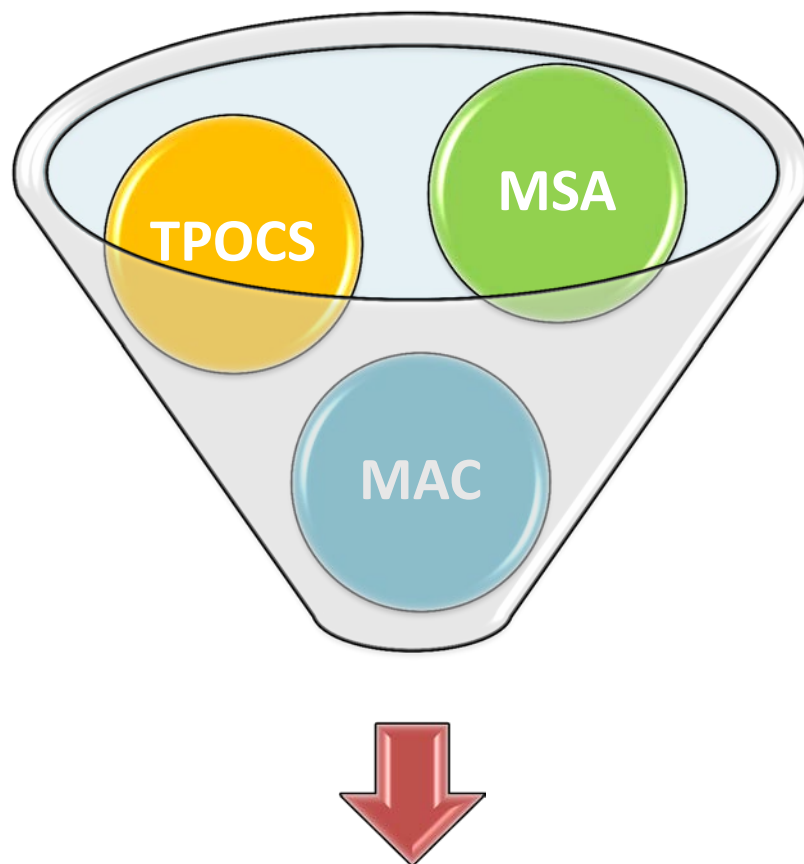

- Single solution to perform billing & collection functions:
 - Medical Services Account
 - Medical Affirmative Claims
 - Third Party Collections





“One” Centralized Billing and Collection System

- Web-based
 - Access via CAC
- Cloud-hosted
 - No server required
- Electronic billing
 - Claims failing edits will be queued for review/correction (“Manage by exception”)

- MSA
 - Cash Collection Voucher
 - AR Management
 - Debt transfer
 - Refund reconciliation
 - Elective cosmetic surgery
 - Bill estimator
 - Other MSA collections
 - Payment plan
 - Dining hall collections



- MAC
 - Manual creation
 - Automated MAC
 - JAG notifies UBO to process claims
 - UBOs generate claims
 - JAG prints and asserts claims

- TPC
 - Electronic clearing house services
 - Capability to medical and pharmacy electronic billing
- Electronic EOBs will speed up posting
- Ability to electronically bill pharmacy
- E2569 process will enable UBOs to promptly link insurance information to claims

- e2569
 - Patient signs via “electronic signature pad”
 - Data stored in database
 - Linked to the individual patient OHI records
- File attachments
 - ABACUS will enable users to attach various file format documents to the patient account level

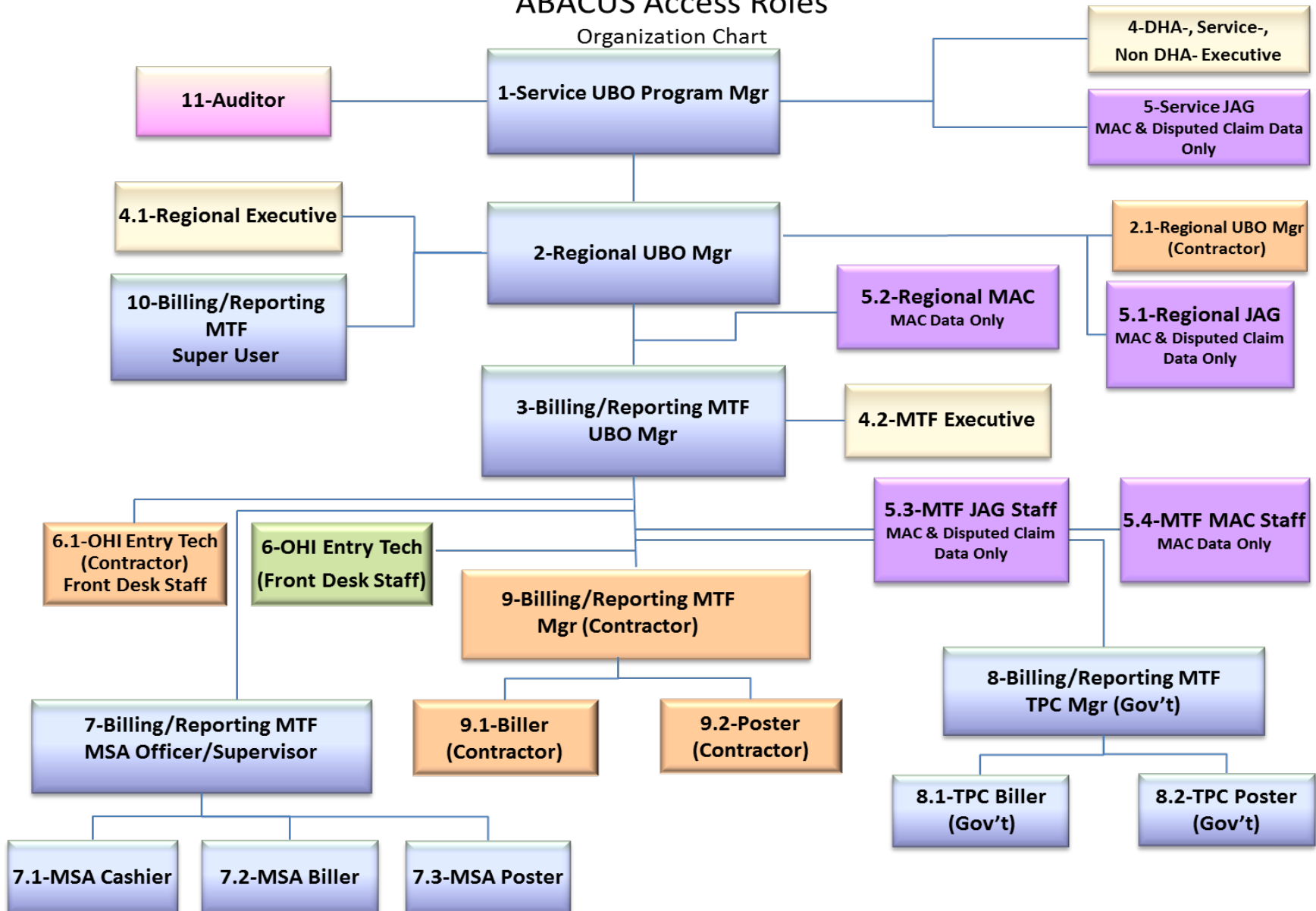
- Account posting
 - Automatically posts ERAs
 - Manually or electronically batch posts from EOB or other documentation
 - Storage of electronic EOBs
 - Automatically reconciles accounts to update customer records and claims
- Electronic OHI discovery

- Interagency invoicing
 - Electronic DD7/DD7A, SF 1080
 - Ability to associate UB-04/CMS 1500 to a SF 1080
- Enterprise reporting (on demand)
 - MARS (formerly known as the 1860-R)
 - A/R reports
 - 2570
 - 2569 status matrix
 - Net realizable value

- Audit readiness
 - ABACUS will enable MTFs to be “audit ready” and comply with DoD Comptroller policies
- Streamlining UBO processes
 - ABACUS will enable UBOs to take advantage of efficiencies and focus on processes that were somewhat neglected in the past
- Greater visibility from top to bottom

- UBO Managers/Supervisors
 - Remain flexible and readily available to support the ABACUS deployment team
 - Submit required documents promptly (ABACUS workbook)
- MTF Leadership
 - Enforce standards to correctly discover/collect OHI
 - Enforce proper utilization of PATCATs
 - Ensure that UBOs are properly staffed to execute revenue cycle operations
