Joint Medical Operations Course (JMOC) - Advanced



JMOC-Advanced is a five-day course that provides training consists of planning activities associated with joint military operations by combatant commanders (CCDRs) and their subordinate joint force commanders (JFCs) in response to contingencies and crises. In addition, in-depth discussion on the comprehensive system that provides uniform policy and procedures for reporting the ability of the Armed Forces to fight and to meet the demands of the National Military Strategy.

HOW WOULD I BENEFIT FROM THIS COURSE?

Advance skills needed to support Joint Health Service Support (HSS) operations :

- ❖ Support the joint medical planning community in the development of the systems analysis, operational risk assessment, and field medical services planning.
- ❖ Coordinate health service support (HSS) including, but not limited to, first responders, forward resuscitative surgery, theater care, en route care, preventive medicine, mental health, dental, and veterinary services, in preparing and sustaining theater forces.
- ❖ Produce medical intelligence (MEDINT) resulting from collection, evaluation, analysis, and interpretation of foreign medical, bio-scientific, and environmental information.
- ❖ Conduct Foreign Humanitarian Assistance and Disaster Response in support of the United States Agency for International Development (USAID), Department of State, and Department of Homeland Security.
- ❖ Establish training programs, execute joint training events and exercises, and assess joint training effectiveness.
- ❖ Support the Chairman's Readiness system that provides a common framework to measure the integration and synchronization of combat and support units into an effective joint force ready to accomplish mission assignments.

WHO QUALIFIES TO ATTEND JMOC-ADVANCED?

- ❖ Target audience: Medical planners and operators.
- ❖ Open to Department of Defense (DoD) medical department personnel assigned to Combatant Commanders, Service Headquarters, Joint Task Forces, and joint organizations.
- ❖ If space available, other DoD medical department personnel and United States Government (USG) Interagency personnel may attend.

FUNDING? This course is not centrally funded. Funding will need to be obtained through your unit.

CONTINUING EDUCATION (CE) CREDIT. JMOC-Advanced provides up to 35 Category I CME credit hours

WHAT ARE THE PRE-REQUISITES?

- ❖ **Must have completed JMOC-Basic (or equivalent) and Joint Medical Planning Tool (JMPT). These courses can be completed immediately prior to JMOC-Advanced.**
- ❖ JMOC-Basic equivalent courses: Joint Medical Operations Managers Course (JOMMC) or Joint Medical Planners Course (JMPC).

HOW CAN I BE NOMINATED TO ATTEND?

Personnel interested are required to submit a "**Nomination Request Form**" to DMRTI no later than eight (8) weeks prior to course convening dates. Nomination Request Form can be accessed through the DMRTI web-site or via
