

TicoVAC (Tick-Borne Encephalitis Vaccine) Ordering Guidance
Updated: 15 July 2022

TicoVAC is currently available through the Pharm PV Program. Two adult packaging options and one pediatric option are available through both AmerisourceBergen and DMS.

CONUS Customers:

TicoVAC is available as a drop ship item. Sites can follow their normal DMLSS/TEWLS ordering process to place a PV order by setting their SOS (Source of Supply) to PVP (AmerisourceBergen) or PV2 (DMS) (your SOS code for DMS may be different) for one of the NDCs below. The adult doses are currently on an active FSS, and the pediatric dose is available on a Regional DAPA. The prices are listed next to each NDC.

OCONUS Customers:

AmerisourceBergen stocks a small inventory of TicoVAC products at their distribution center(s) to support OCONUS requirements. The products must be ordered in their DMLSS/TEWLS using one of the **PVONs (Prime Vendor Order Numbers)** below instead of the NDCs. For the adult formulation, only the 10-pack option is offered to OCONUS customers. The pediatric dose is currently being set up and will be available to order using the PVON below once the set is complete.
