2. Once the stopper of the Afluria® multidose vials are pierced the vial must be discarded within 28 days. The number of needle punctures should not exceed 20 per multidose vial. 3. Afluria® is licensed for administration by needle and syringe (6 months and older) or by PharmaJet Stratis® Needle-Free Injection System (18 through 64 years).

4. The approved dose volume for Afluria Quadrivalent is 0.25-mL for children 6 through 35 months and a 0.5-mL dose for persons aged ≥3 years. However, 0.25-mL prefilled syringes are no longer available. For children aged 6 through 35 months, a 0.25-mL dose must be obtained from a multidose vial.

5. Fluzone® Quadrivalent is currently approved for ages 6 through 35 months as either 0.25-mL or 0.5-mL per dose; however, 0.25-mL prefilled syringes are no longer available. If a prefilled syringe of Fluzone Quadrivalent is used for a child in this age group, the dose volume will be 0.5-mL per dose.

6. No more than 10 doses (0.25-mL or 0.5-mL) should be withdrawn from the Fluzone® multidose vial.

7. Fluad[®] includes the MF59C.1 adjuvant (MF59®), a squalene-based oil-in-water emulsion.

8. Quadrivalent inactivated vaccine high-dose: a 0.7-mL dose contains 60 µg of each vaccine antigen (180 µg total).
