A Joint Program under the Leadership of the Chief of the Army Nurse Corps, the Director of the Navy Nurse Corps, and the Air Force Assistant Surgeon General for Medical Force Development and Assistant Surgeon General for Nursing Services

Mission: To facilitate nursing research to optimize the health of military members and their beneficiaries.

Goals:

- 1) Expand the Cadre of nursing research:
- 2) Expand the breadth and depth of the nursing research portfolio by encouraging and funding programs of research in TSNRP's focused areas of investigation
 - Promote research in:
 - o Force Health Protection
 - Fit & Ready force; Deploy with and Care for Warriors, Care for all entrusted to our care
 - Nursing Competencies and Practice
 - Patient outcomes, quality and safety; Translate research into practice/Evidence-Based Practice; Clinical Excellence; Knowledge management, education and training
 - Leadership, Ethics and Mentoring
 - Health Policy; Recruitment and retention; Preparing tomorrow's leaders; Care of the caregiver
 - Support a range of studies encompassing new investigators through large-scale, multi-site studies
 - Promote projects addressing the translation of knowledge and research findings into evidence-based practices in a military context;
- 3) Foster partnerships for collaborative research;
- 4) Provide an infrastructure to stimulate and support nursing research and Evidence-Based Practice.

Background:

Congress established the TriService Nursing Research Program (TSNRP) in 1992 and tasked the TSNRP to "support research conducted by military nurses" (S.R. 107-732). The TSNRP was authorized as part of the Department of Defense Health Care Program and established at the Uniformed Services University of the Health Sciences (USU) in 1996 for regulatory and fiduciary oversight (Chapter 104, Title 10, U.S. Code, as amended). The TSNRP is under the leadership of the Chief of the Army Nurse Corps, the Director of the Navy Nurse Corps, and the Assistant Surgeon General of the Air Force Nurse Corps. Through continuing investment of resources, guidance from Federal and private sector nursing leaders and support from the Congress, TSNRP research has yielded valuable outcomes as military nurse investigators have successfully initiated efforts to expand the scientific foundation of military nursing into the patient care environment.

Program Management:

Current infrastructure is based on 1996 Institutes of Medicine (IOM) Report titled, "The Program of Research for Military Nursing"

- Proposal Review is three-tiered; 1) Scientific Review, 2) Programmatic Review, 3) Executive Board of Directors Review.
- Since being established in 1992, TSNRP has funded >\$60.1M in research grants. 52.7% of the monies have gone to active duty nurse researchers and graduate students, 28.6% to active reservists across the country; 16.9% to retired military nurses in university settings; and 1.8% to active National Guard members.
- Approximately 303 of 799 submitted applications have been funded for a 38% overall funding rate. More than 650 military nurses have participated in TSNRP supported research teams.
- TSNRP provides a mandatory Post-Award Grant Management Workshop to all Principal Investigators to provide regulatory information on conducting studies and managing grants.
- Investigators have published in over 90 peer-reviewed multidisciplinary healthcare journals and disseminated their research findings via posters and presentations at national and international healthcare and specialty conferences.
- Each service is provided an updated book of all current funded studies, organized by service.

- TSNRP is committed to providing opportunities for development of researchers through the following offerings: Grant Camps I and II, Evidence-Based Practice Grant Camps, Advanced Researcher Forum, Novice Researcher Development Course, Publication Workshop and various other educational offerings.
